Lovington EDC would like to invite Businesses or Building Owners within Zone "E" to apply. By offering this grant our hope is to jump-start private investment in Lovington and encourage economic development growth. This is a matching grant for the improvement and rehabilitation of commercial properties as storefronts of retail, restaurant and entertainment for-profit business. Lovington EDC will award a maximum of \$50,000 a year for the next 3 years. This is a competitive selection process, all applications will be received and reviewed by the Lovington Economic Development. For further information contact the Lovington EDC office.

- Electrical and Plumbing Upgrades
- Replacement of Masonry or Brick

- Hazard Abatements
- Heating, Ventilation or Air Conditioning
- Fire Sprinkler System Installation or Upgrades
- Other Infrastructure Improvements: as approved, with significant impact on the building owner's ability to attract highest/ best use of tenants and/or increase sales for current tenant.

RFP-Housing Incentives



The Lovington Economic Development Corporation and The City of Lovington are seeking Housing Developers to provide Housing Production Services to increase the supply of additional family housing units within the Lovington City Limits. The EDC is aware of the severe shortage of housing currently in Lovington and the surrounding areas causing a substantial disadvantage to the City's economy and economic development. The EDC and The City of Lovington will provide funding to the developer for "Housing" defined as a permanently constructed/ installed, rental or for-sale housing development, in any combination of modular, manufactured, or site built. Other qualifying infrastructures are newly constructed streets, sidewalk, and utilities, with these infrastructure items to be designed and installed by the developer. The minimum project development size is 4 housing units per project location. All proposals must be received on or before June 30, 2021, or as long as budgeted funds (\$450,000.00) for market-rate housing incentives are available, if earlier than June 30, 2021. RFP can be found on the City of Lovington website or the Lovington EDC Offices. All proposals shall be mailed or hand-delivered to 201 S. Main in Lovington.
